#### St Stephen Lutheran Church 2021 Virtual Congregational ANNUAL Meeting Minutes January 31, 2021

Betsy Clark called the virtual meeting to order at 12:02 pm via ZOOM. There was a quorum with 58 people in attendance.

Opening Devotions – Pastor Jim Woodruff. Psalm 62:5, 6 & 8 – For God alone my soul waits in silence, for my hope is from him. He alone is my rock and my salvation, my fortress; I shall not be shaken. Trust in him at all times, O people; pour out your heart before him; God is a refuge for us.

#### Approval of the 2020 Congregational Meeting Minutes - Betsy Clark

A motion was made to approve the 2020 Annual Congregational meeting minutes by Randy Amborn; 2<sup>nd</sup> by Judy Gelderman. Voted on and approved.

#### Lead Pastor's Report - Pastor Jim Woodruff

Report posted in the 2021 Annual Report. With the sudden onset of the COVID-19 global pandemic, all life normalcy was interrupted with the need to delay, revise, restructure, amend, modify and adapt. The development of new and innovative ways to worship together and new ways to stay in touch were found. A new committee, the COVID-19 Response Team was created. This team worked tirelessly to develop a plan for safe-health and continued business operations. They did this following the guidance from the CDC, MDH, St. Paul Area Synod and Governor Walz's Office. Church staff, Ministry Teams, Church Council all had to redefine and restructure everything that they knew as normal. Continued worship has been made possible through an online format on Sundays and Wednesdays. We expect to continue this after we resume in-person worship. All large group events were put on hold. Following our Preparedness Plan we have maintained several small group meetings of 10 participants or less. Despite the pandemic, continued support was able to be given to support our international missions. With congregant giving having remained consistent and unwavering AND with the forgiveness of the Paycheck Protection Program loan, we are going into 2021 with a positive carry-over balance of over \$20,000.

#### Visitation Pastor's Report - Pastor Juli Thompson

Report posted in the 2021 Annual Report. Due to the global pandemic, phone calls replaced inperson visits to minimize the dangers of infection. The role of the COVID Response Team chairperson was taken on requiring many hours by all. Participation in the Sunday on-line services were made possible thanks to the technical skills of many dedicated staff.

#### Church Council President's Report - Betsy Clark

Report posted in the 2021 Annual Report. In July, Ted Field resigned as Council President, and Jessica Rotschafer resigned as Vice President. These positions were filled by Betsy Clark as President and Ken Smith as Vice President thru the remainder of 2020. Appreciation to Ted for the creation of the Cash Reserve Fund and Jessica for her leadership as Vice President. They both currently serve on the COVID Response Team. The authorization of two Continuing Resolutions in our Constitution, Bylaws and Continuing Resolutions document were necessary to allow Congregations and Council to meet remotely. The 2020 Phase 1 Furnace Replacement Project was put on hold, now with a current plan to begin in the Spring (retroactive to April

2020). Council approved the purchase of needed specialized audiovisual equipment that will further be addressed in 2021. Because of the congregant's generous and consistent support and the PPP loan, we start the new year with a positive budget balance. Welcome council President, Ken Smith, along with new council members Kristin Duffy, Marta Hohnstadt, Chris Sheldon and Abby Ternus. Thank you to outgoing council members Ted Field, Jessica Rotschafer, Jodi Millard and Randy Amborn for their service and thank you to the COVID Response Team for their diligent persistence and dedication.

#### Acceptance of Ministry Team & Special Annual Reports - Betsy Clark

A motion was made to approve and accept the Ministry Team and Special Annual Reports by Betsy Clark; 2<sup>nd</sup> by Karen Smith. Voted on and approved.

The position of Vice President is currently vacant.

#### Nominees for the 2021 Nominating Committee

A motion was made to accept Randy Amborn, Jodi Millard and Patsy Olson to the 2021 Nominating Committee by Robin Schreoder; 2<sup>nd</sup> by Allie Schenian. Voted on and approved.

#### Installation of 2021 Church Council - Pastor Jim Woodruff

The 2021 church council members were presented to the congregation and installation progressed.

#### Treasurer's 2020 Report – Patsy Olson

Report posted in the 2021 Annual Report.

Current Fund: \$20,614.74 Capital Fund \$117,953.01 Benevolence Fund: \$132.37

Special Designated Fund \$76,306.31

Cash Reserve Fund: \$17,641.21

We were able to receive a PPP Loan (Paycheck Protection Program) for \$47,900. in April 2020. This loan was forgiven in January 2021. To qualify for this loan again in 2021, we must have a 25% decrease of income in any given quarter compared to the previous year. Thus, it would be necessary for the perimeters to change. The 2021 budget is \$11,965.70 lower than the 2020 budget.

A motion was made to accept the 2020 Treasurer's Report by Randy Amborn; 2<sup>nd</sup> by Jessica Rotschafer. Voted on and accepted.

#### Introduction to 2021 Budget - Ken Smith

Reports posted in the 2021 Annual Report. The 2021 proposed budget is \$430,668.57.

#### 2021 Budget Review - Ted Field

This proposed budget is less than last year and previous years. We ended 2020 with a surplus balance of \$20,614.74. It must be noted that this is not our 'normal trend'. Less operational expenses and the PPP loan are what turned our expenses around in 2020. Should there be an opportunity to again apply and qualify for a PPP loan in 2021, we will. In the future, we cannot plan our budgets with this assumption. The 2021 proposed budget includes staff salary increases that has church council approval. The proposed staff salary increases are approaching Synod guidelines.

#### Congregational vote

A motion was made to pass the 2021 budget by Ted Field; 2<sup>nd</sup> by Marta Hohnstadt. Voted on and passed.

#### GOD IS WITH US (Reprint from 2020 Annual Report)

"For God alone my soul waits in silence, for my hope is from him. He alone is my rock and my salvation, my fortress; I shall not be shaken. Trust in him at all times, O people; pour out your heart before him; God is a refuge for us." Psalm 62:5, 6 & 8

These words, attributed to King David nearly three thousand years ago, are words that ring true today as strongly as they have for the past three millennium. No matter what has happened this year; no matter how difficult this year has been; no matter what disappointments, what frustrations, what loneliness has encroached upon our lives; no matter what losses we may have suffered; no matter what relationships have been strained; no matter how unfamiliar, uncertain, unique or challenging this year has been, David's words keep us grounded in truth and give us confidence that we are not in this by ourselves. God is with us every step of the way. In God we have hope! God is a solid foundation and protection for our lives! Our call is to trust in Him at all times. Before Him we can pour out our heart! And no matter what circumstances we face God will always be for us a refuge! One of the great lessons I hope we've learned these past two years is the reminder that through it all God is with us; we are never alone.

#### DO NOT FEAR, FOR I AM WITH YOU

"But now thus says the LORD, he who created you, O Jacob, he who formed you, O Israel:

Do not fear, for I have redeemed you; I have called you by name, you are mine. When you pass through the waters, I will be with you; and through the rivers, they shall not overwhelm you; when you walk through fire you shall not be burned, and the flame shall not consume you.

For I am the LORD your God, the Holy One of Israel, your Savior....

Because you are precious in my sight, and honored, and I love you,....

Do not fear, for I am with you;... Isaiah 43:1-5

As I've reflected back on my introductory statement for the 2020 Annual Report, it has occurred to me that there is a second part to the thought that "God Is With Us", (we are never alone, we do not go through the experiences of life apart from the presence of God). That second part is that because God is with us we need not fear. To repeat from last year: "No matter what has happened these past two years; no matter how difficult it has been; no matter what disappointments, what frustrations, what loneliness has encroached upon our lives; no matter what losses we may have suffered; no matter what relationships may have been strained; no matter how unfamiliar, uncertain, unique or challenging this year has been", no matter how unstable these two years have felt, we recall that God has been with us all the way, God will continue to be with us, and because we go through life with God, the fears that we so easily let creep into our lives really can have an entirely different context when we remember with Whom we walk. Living without fear doesn't give us a license to be cavalier about life. We do have a responsibility to make good choices and to do our best to not put ourselves or others in risky situations. But we can't hide from life and, knowing that God is with us we move forward in confidence seeking, even in the midst of the uncertain and chaotic time in which we live, to bring hope, optimism, light and life to all those who are within our circle of influence. May fear not guide our decisions or direct our actions; may our trust in a loving God keep us moving forward.

#### WHAT WE'VE BEEN DOING

We began 2021 continuing to offer on-line pre-recorded worship services on Sundays and Wednesday nights. Paige Carter, Justin Woodruff, Cindy Bittner, along with Randy Amborn and Brent and Betsy Clark have become adept at creating musical numbers to fill those pre-recorded services. Melissa Whitman has become skilled as editor for those services. In Lent we resumed in-person worship, first in the Fellowship Hall, then before Easter on Sundays in the Sanctuary and continuing on Wednesdays in the Fellowship Hall. Summer saw the reintroduction of Barbeques before our GAP outdoor worship as well as several outdoor Sunday morning worship services. In April and May we had raised money for live-streaming capabilities in the Sanctuary which came on line in July. Children's Ministry and Confirmation also resumed during Lent. Both used a hybrid model for instruction (in-person or on-line). Slowly through the year small group learning and some community outreach programs resumed in-person operations. In July the Senior High Youth Group did a mission trip to San Francisco. In October we partnered with Redeemer Lutheran Church in teaching our Confirmation classes and began to build a Collaborative youth ministry with five congregations in White Bear Lake. Some larger group events also re-booted in-person after summer; Rally Day Picnic, the Holly Boutique, Living Nativity. Other large events remained on hold both due to Covid concerns as well as staffing limitations; Night to Unite, the Music Festival and Auction, Trunks 'n Treats. We continued providing meals on Wednesday night as we moved into the Fall. Through all of the upheaval of the past two years we've learned some positive new ways to function. ZOOM meetings are a wonderful alternative for some Ministry Teams and we've discovered new use for some space; GAP works wonderfully in the Fellowship Hall when we're indoors and the Holly Boutique was thrilled with using the Fellowship Hall for its event; all good options as we move into the future. Our first furnace project (1 of 3) was finally able to be completed, after supply shortage issues and Covid restrictions were eased. Mid-fall a delivery truck struck our west entrance canopy and knocked it about two feet off its axis. That led to several months of not being able to use the west entrance and eventually a significant repair job. The reconstruction/repair work is done, but we're waiting until spring to complete the aesthetic work. We have continued to support our international missions; both our student, capital, and shared commitments to Lukani Lutheran Church, our Companion Congregation in Lukani, Tanzania, as well as our support of Rancho San Juan del Bosco, the orphanage in Tecate', Mexico.

#### WHAT WE ANTICIPATE DOING IN 2022

All future activities are subject to revision depending on the trends of the global pandemic. With that in mind, worship should continue as it has for the past 9 months. We'll continue to offer livestreamed Sunday morning services, and work toward the ability to resume live-streaming on the Wednesday evening GAP worship services. Children's Ministry will continue on Sunday and Wednesday with some added summer activities, notably Wapogasset Lutheran Bible Camp and Vacation Bible School. Youth Ministry will get a boost in February as we partner with Redeemer Lutheran Church to carry out opportunities for fellowship, service, growth and worship among our young people. I'm hopeful Night to Unite and the Music Festival and Auction will resume. The Tanzania Mission Team is anticipating carrying out our every three year Mission Trip to Iringa/Lukani, sometime between August and October. We will also seek to grow our levels of participation in all events as the pandemic subsides. (Currently in-person participation is a little under 50% of pre-pandemic numbers.) We will make a concerted effort to solidify our future financial stability as we promote our Cash Reserve Fund and introduce opportunities to grow the St. Stephen Endowment Fund through the ELCA Foundation. Springtime weather will allow us to complete the west entrance rebuild/remodel as we add additional shrubbery, decorative covers on the supporting posts, add a 'peace pole' in memory of Lorna and Wendell Peck along with several secured benches. We are also moving ahead to replace our original furnaces this summer, part 2 of a 3 part replacement of our whole Hvac system.

#### FINANCES, REFLECTING A FAITHFUL AND GENEROUS PEOPLE

Once again the generous characteristics of the people of St. Stephen have shown through. In spite of the uncertainty of the pandemic we finished the 2021 fiscal year with a positive balance of \$9,139.36 in our Current (operational) Fund. Two contributing factors in this positive cash flow were the residual blessings of the PPP forgivable loan we received in 2020 (≈\$20,600.00) and the five months we did not pay a salary for a CYF Ministry Director (≈\$23,500.00). Had those not influenced our Current Fund we could have finished with a \$10,000-30,000 deficit. This coming year will remain a financial challenge for us and has caused us to think 'out of the box' as we look to continued ministry in 2022. One of the ways we intend to address this challenge is to hire Paul Schultz (currently Interim Children's Ministry Director) as part-time Children's Ministry Director who will donate some of his time as a gift to the congregation. We are also implementing a plan to partner with Redeemer Lutheran Church, which is in a similar situation to us. We will split the cost of the Youth Director portion of their budget, 1/4 of a full time salary package and will carry out a joint youth ministry in both congregations, sharing time and space and creating a larger youth group as a result. We believe this will make a more vibrant and engaging youth ministry. These changes will benefit both churches and affect our budget by dropping costs of our Children, Youth and Family Ministry to about what we paid in 2021 for 7 months of a CYF Director's package. Our other Funds are all healthy. The Benevolence Fund ends the year near zero, as we donate all the money in that fund to organizations and ministries outside our walls. The Capital Fund is just under \$100,000 and can fully provide the income needed to do our second furnace project. That Fund is stable and continues to grow about \$30,000 each year. Our Designated Fund is also healthy with assets of \$86,000. This Fund enables us to carry out a variety of projects in and around the Church as well as in our wider community. Our newest Fund, the Cash Reserve Fund, is continuing to grow and is designed to provide a cash cushion for our operations, especially during summer months when the Current Fund makes its annual dip. This Fund is not meant to make up any year-end deficit, but rather to provide cash flow so we don't have to borrow money either from the bank or from our own capital or designated funds, and allow, especially, the Capital Fund to be used as it is intended. The goal is to grow that Fund to \$90,000. After two years since its inception we're currently at about \$30,000. If the growth for this Fund continues at the same pace it'll take us another four years to reach that goal. That's ok; we need to be committed to see it happen. Finally, this year we will be reintroducing the St. Stephen Endowment Fund, with the intent of providing opportunity for legacy gifts, estate gifts, and bequests to strengthen the longterm financial viability of the congregation and provide extra monies to carry out new and creative ministry above and beyond regular giving. St. Stephen is in a good financial position as we move into the future. May our vision for the future be strengthened by our faithful and generous ongoing support.

#### **GODS' PEOPLE IN THIS PLACE**

We are a people with diverse gifts, interests and passions. In this place God has provided opportunity for each of us to use our gifts, demonstrate our care and serve as Jesus served. Each member of this congregation deserves specific mention for we all contribute to the life of this place. Because I can't name everyone, I'd like to highlight a few. First, the **Church Council**, which has been especially important during these two years of Covid. The Council has consisted of Betsy Clark, Paul Colaizy, Kristin Duffy, Marta Hohnstadt, Ted Schaff, Chris Sheldon, Ken Smith, Mira Stearns, and Abby Ternus. Special thanks to those who are completing their terms on Council and to those who are continuing on. Also thanks to Ken Smith for his leadership as President of the Council during these tumultuous times, and to Mira Stearns who will be assuming that role this coming year. Thanks to our **Church Officers**: Teri Cinis, Council Secretary (now retired), Brad Wilm, Financial Recording Secretary, and Patsy Olson, Treasurer. Each has provided faithful service 'above and beyond'. I also want to acknowledge our

Ministry Teams and Ad Hoc Committees, who have taken on extra responsibilities these past two years: Finance and Stewardship, Property, Staff Relations, Women in Ministry, Worship and Music (who led our efforts to raise funds for our Live-streaming system), the Interim CYF Team, the Endowment Committee, the Gift Committee, the Hospitality Committee, the Wednesday Evening Dinner Crew, special Event Coordinators, and all Worship Leaders - lectors, ushers, and volunteer musicians. The service of each of you has brought vitality and vision to this congregation. Finally I want to acknowledge the consistent and immeasurable efforts made by all our Staff. For eight vears we've had an incredibly stable staff. This year, during the second year of pandemic, we've experienced significant change. Paul Swanson has continued on as half-time custodian, but Bob Blumberg, after eight years has retired. In mid-December Greg McGuiggan took on responsibilities as our other half-time custodian. All three have been and are conscientious and enjoyable to work with. Tami Heart has been here nine years and continues to be a delight in the office and faithfully carries out her responsibilities. Patsy Olson, while not paid staff, spends significant time in the office managing our finances and brings her laugh and a positive voice to our planning. Melissa Whitman, also after eight years of faithful ministry as Children, Youth and Families Director and jack-of-all-trades, went to our neighboring church to bring her creative, relational style of ministry there. She will be returning on a part-time basis as we develop a partnered youth ministry with Redeemer Lutheran Church. Paul Schultz has taken on the responsibility for Children's Ministry and is doing a wonderful job. Andrew Bjork, our Social Media Administrator, continues to make a significant impact in the social media awareness of St. Stephen. Zach VanDyke has been hired as our Digital Media Coordinator, primarily responsible to manage our live-streaming and on-line video spots. Pastor Juli Thompson is a flexible and effective pastoral partner. She is beginning her fifth year at St. Stephen. Our whole music staff have gone above and beyond their responsibilities as we've navigated this pandemic. All have taken extra time to learn new recording skills and/or spent additional time making recordings for our pre-recorded worship through June. Cindy Bittner for thirty years has offered skilled music leadership every Sunday and for special Paige Carter had completely different responsibilities these past two years as Contemporary Worship was put on hold and pre-recorded worship became the norm. resigned in June and has since moved to the state of Wyoming. Justin is faithfully and enthusiastically leading worship every Wednesday; now for fifteen years. Kari Ballata joyfully directs and manages the Senior Choir in spite of the ups and downs caused by the pandemic. We wish Bob, Melissa and Paige all the best as they move on to new ventures. I continue to be pleased and thankful to serve as Lead Pastor at St. Stephen. You're a wonderful congregation!

#### **Visitation Pastor**

2021 Annual Report

This year has not been what we expected! We continue to grapple with the pandemic and the changes that it has made for every aspect of our lives. We have been hoping to end the need for mitigation and been disappointed to have restrictions reappear.

I continue to do most of my visitation by phone. I am regularly calling the people on my list of sick and shut ins, and I try to touch base regularly with everyone on the prayer list. In addition, I am working my way through the directory, as time allows. If you haven't heard from me, it's because I just haven't gotten to you yet!

I was able to resume visits this year for some people. As of November, the hospitals are no longer allowing clergy visits and many care centers are similarly restricted. I have been able to continue to call on those who are in hospice. I can call on people in their homes, at their discretion, and I try to schedule those to minimize the possibility of carrying infection from household to household. I was able to resume my monthly worship services at Willowwood, and those will continue in the new year.

As I have gone about my visitation duties, I am concerned about the way that the pandemic is affecting us. It is isolating us from one another, obviously. St Stephen is addressing this by having worship opportunities (on-line and in person), having opportunities to gather safely, and making every effort to connect with members via phone and mail.

It is also setting us against one another. No one can be unaware of the degree to which we are encouraged to blame one another, and how we have come to live almost in different worlds, based on our media, our politics, our entertainment, or other differences. St Stephen is addressing this by calling all members to remember that the true source of our identity is in Jesus Christ. Through worship, sacraments, and prayer, we can differ in profound ways without rejecting our shared unity in Christ.

I also see profound grief, often unexpressed. Almost a million of our fellow citizens have died. Our understanding of what it means for children to be in school has profoundly changed. We are missing friends, families, celebrations, and gatherings. The way we work, shop, eat, and simply exist has been changed. All of these changes are unsettling. We grieve for what we knew, for what we have lost, for a sense of surety about what the future will be like. St Stephen is addressing this by offering opportunities to acknowledge and talk about these feelings. We have started an online "Psalms for Daily Prayer" section of our website that allows anyone to join in these prayers, often written from depths of grief, fear, and anger. We are also planning for grief support groups (in addition to the long-standing one that many are familiar with).

Through all of this, St Stephen has modeled trusting in God's grace and love in difficult circumstances. We are called to be his hands and feet in this world, we are blessed to be a blessing to all those around us. Rather than turn inward, St Stephen has opened itself to the community around us, and we constantly seek new ways to show God's love.

I am blessed to be part of such a community.

#### **Church Council President**

2021 Annual Report

Covid 19 has continued to have an outsized impact on day to day functioning of St. Stephen during 2021. We strive to adapt as needed yet maintain a vibrant and mutually supportive worship community. And as we approach two full years of the pandemic our church family has adapted in many ways. We moved back into in person worship midyear while simultaneously broadcasting services live to reach congregants unable to attend or uncomfortable with attending worship in person. A special appeal was successfully completed which allowed us to install the live streaming system without dipping into our capital funds. Our mask mandate was lifted although we still encourage everyone to wear masks in accordance with Minnesota department of health recommendations. Council and many committees meet regularly using Zoom. Flexibility, safety and an ongoing respectful dialogue are my personal priorities as our church and, frankly, our world learn to live with the continually evolving Covid virus. Thanks to all of you for your faith, presence, support and perseverance during 2021!

#### **Financial Stability into the Future**

**First – a big thank you to Patsy Olson.** She has continued to serve admirably as St. Stephen treasurer. As I write the following any <u>accurate</u> numbers are thanks to Patsy (and any <u>inaccuracies</u> are solely my responsibility).

- Cash reserve fund: Our cash reserve fund continued to grow during 2021 and now totals ~\$28,000. This fund, with a goal of \$90,000, is intended to permanently free up our need to draw funds from our Capital Fund to pay our bills as month-to-month shortfalls happen.
- Capital fund: Our capital fund is healthy with a year-end balance of ~\$99,000. The canopy and front entrance were repaired and replaced, respectively, just before winter. While capital funds were used temporarily, these should be completely recovered from insurance proceeds and further replenish the fund. Capital funds were also used to replace furnace #1 in June, the first of three furnaces the congregation voted to replace. Replacement of another furnace (likely #3) is considered in 2022, pending receipt of a revised quote for council review.
- **Budget**: St. Stephen entered 2021 with a carry over balance in our current fund of over \$20,000, primarily due to forgiveness of our Paycheck Protection Program (PPP) loan. We knew that 2021 would be financially challenging since we were no longer eligible for PPP funds. **However, at year end we ended with current fund surplus of ~\$9,100.** Thank you all for your consistent and unwavering financial support of St. Stephen's ministry!!

**Staffing updates:** We bid farewell to long time staff including Melissa Whitman (Children, Youth and Family Ministries director), Bob Blumberg (half time Custodian) and Paige Carter (Contemporary Worship). **Thanks to them for their many contributions to life at St. Stephen.** We welcomed Zach Van Dyke (Digital Ministry Director), Greg McGuiggan (half time Custodian) and Paul Schultz (Children's Ministry).

**Shared ministries with Redeemer Lutheran church**: We started to successfully work in cooperation with Redeemer on shared Youth Ministries during 2021. Both churches have their individual and unique identities, histories, and cultures. However, I believe shared ministry in some areas may be beneficial to both congregations and are worth exploring. Additional opportunities for collaboration will be carefully considered in the coming year.

Our **Annual Meeting** will be held in person in the sanctuary on January 30, 2022 starting at 1 pm. We need the in person participation of at least 35-40 people to meet a quorum so please mark your calendars and consider attending. To encourage in person participation, church council will likely require masks at this meeting (not yet approved at the time this report was written). Holding the annual meeting in the sanctuary allows us to simultaneously broadcast live to those unable to attend in person. We encourage those attending online to listen to the discussion and submit questions. However, voting on motions will be limited to those physically present since the live broadcast system does not allow us to record votes.

I'd like to personally thank outgoing church council members for their service: Abby Ternus, Kristin Duffy, Marta Hohnstadt, Paul Colaizy, and Ted Schaff. It's been a pleasure working with you and your leadership this past year is greatly appreciated.

#### **Children and Families Ministry**

2021 Annual Report

2021 saw the slow but sure return of some sense of normalcy in our programing. Late winter through early spring saw the return of in-person Wednesday School, pre-confirmation and Confirmation classes. Vacation Bible School was held in August. Sunday School began in person classes in the fall. This was accomplished with a heighten sense for safety as we follow all the health, safety and cleaning protocols set in place to keep our children, youth, staff, families and congregation safe and protected.

Though our numbers are small, they are enthusiastic and energetic to learn about God's world and the life of the people in the Bible. Vacation Bible School 'Knight's Castle' saw approximately 30 students and 15 adult/youth volunteers "Be **strong** in the **Lord** and in the **strength** of his **power**." #### **Endowment Committee**

In 2008, an Endowment Fund was established to support three ministries:

- Children, Youth and Senior programs
- · Worship, Music and Hospitality
- Mission

Since the establishment of the Fund, St Stephen has accumulated \$6,105.00 (this money is being held in a St. Stephen Special Designated account).

The minimum amount for opening an endowment fund account is \$25,000.

In 2019, the Church Council appointed an Endowment Committee to review the Endowment Fund Bylaws, make changes as needed, and promote endowment fund giving.

The Endowment Committee members include Ted Field, Viki Bosin, Jill Sandvik, Pastor Jim and Lee Branwall.

- Step 1) Find a fund management company: We have chosen not to continue with "InFaith" and have chosen "ELCA Foundation" to manage our fund.
- Step 2) Review By-Laws and change as needed: This is done and will be presented as a continuing resolution to the Church Council for approval. We also fine-tuned our Vision for our future: To provide long-term planning to preserve the vitality and stability of our Church, our ministries, and our community outreach programs.
- Step 3) Raise money to open account: The Endowment Committee is going to team up with the ELCA Foundation to provide gift giving education to the congregation.

In the next few months look for more information from the Endowment Committee as we work toward our goal!

#### **Gift Committee**

#### 2021 Annual Report

In 2019 the Council appointed a Gift Committee to review SS gift policy.

The members include Denise Ashley, Anne Jackson, Brenda Steady, Jill Sandvik, Pastor Jim and Lee Branwall. Thank you for all your hard work.

#### Overview of guidelines:

- When St Stephen receives a gift, that is not part of current fund or pledged giving, the gift can be either restricted (given for a particular purpose) or unrestricted.
- When a gift is restricted it is the Gift Committees job to inform the family and track these gifts.
- The family, working with the gift committee has up to two years to decide the exact
  use of the gift. If the gift is not restricted by the end of two years, it becomes an
  unrestricted gift and may be used at the discretion of the Gift Committee.
- If the gift is not large enough for the proposed purpose, at the discretion of the gift committee, the gift may be combined with other restricted (for the same purpose) or unrestricted gifts to fulfill the family's wishes. The gift committee will make every effort to fulfill the family's wishes.
- The gift committee will oversee the completion of the project.
- Unrestricted Gifts may be used for any purpose, as determined by the gift committee, with input from the pastor and finance team.

The revised Policy as written in our Constitution is as follows:

#### C13.09.A22. Gift Committee Responsibilities

- Memorial Gifts: A memorial fund is set up to honor a person. This gift is considered unrestricted or restricted based on the definitions below. When Memorial Gifts are received:
  - a. The family name and the family contact information will be recorded with the proposed use of the fund. These gifts are considered restricted for a period of two years from the time this fund is established. (The date the fund was established should be noted in the name of the fund in the accounting system)
  - b. The purpose of the fund must be agreed upon by the gift committee and the family. The use or purpose for the fund must be in writing.
  - c. The gift committee will provide to the giver written instructions on how the gift will be used and how left-over funds will be distributed.
  - d. If the fund does not reach the dollar amount necessary for the stated purpose or use, the gift committee will contact the family in a timely manner to suggest an alternative gift or seek to join it with other memorial gifts.
  - e. Upon the 2-year anniversary of the gift, if the fund is unused, the funds are considered unrestricted unless otherwise directed by the family. The funds may be used for any purpose the gift committee, with input from the pastor and finance team, deems appropriate.

 Unrestricted Gifts: All gifts given without written instructions will be considered unrestricted and may be used for any purpose by the gift committee, with input from the pastor and finance team, as deemed appropriate.

#### 3. Restricted Gifts:

- a. All gifts given with written instruction are considered restricted funds and cannot be used for any other purpose without express permission from the giver.
- b. All restricted gifts must be approved by the gift committee.
- c. The gift committee will provide to the giver written instructions on how the gift will be used and how left-over funds will be distributed.
- d. If instructions are vague and broad, i.e. "use as you see fit or whatever you need," this gift will be considered an unrestricted gift (see above).
- e. For a gift to be approved it must be deemed appropriate and large enough for the project or fund. If the gift is not usable at this time, the chair of the gift committee will notify the giver and discuss alternatives or seek to join it with other memorial gifts. Left-over funds after the project is completed can be used as the gift committee sees fit.
- f. The gift committee will oversee the record keeping of the restricted gifts.
- g. The committee will have responsibility for cleaning up and consolidating our current special designated funds as follows:
  - i. The committee will go through the special designated and memorial funds and determine on a line by line basis what each gift is for and who gave it
  - ii. The committee will record that information and determine which accounts are considered restricted.
  - iii. The committee is expected to contact the appropriate parties to determine the use of each account. They will determine if the special designated and memorial funds can be used for another purpose (this action would be deemed appropriate if too much time has passed or there is no documentation of the use of the fund or who gave it).
  - iv. The new use of the funds shall be recommended to the congregation council by the committee.
- 4. The gift committee will oversee thank you and gift acknowledgements as appropriate.
- 5. The gift committee will present recommendations for any changes regarding funds to the Congregation Council for approval.





While briefly in the Iringa area in October, Karen and Ken Smith were able to have a day visit to Lukani. It was wonderful to see so many friends and meet the new pastor Steven Maketa (on the left below, presenting a chicken to Pastor Lwila of Bega Kwa Bega). We were greeted with a purposefully smaller group in order to maintain social distance and be respectful of everyone's safety. Our visit and a meal were in the main church because this the much larger building made it easy to maintain some spacing. Nonetheless it was a wonderful meeting with village and Lukani congregation leaders.



As the Covid 19 pandemic continued through 2021 you might be surprised to learn that the impact in Lukani has continued to be relatively low. Dr. Ngure in the Lukani medical clinic reported to us in October that some covid infections were seen from the third (Delta) wave in May through July but that no deaths were recorded.

The water system which was dedicated in 2019 continues to serve the village with clean and safe drinking water. **Thank you** to the members of our congregation who supported this large capital program which was designed by the University of Minnesota students and installed by St Paul Partners. An extension of the system to the final part of Lukani village is under consideration. Safe water has been even more important during the pandemic.

As always, the St Stephen congregation continues to support secondary school scholarships for ~15 students with money from benevolence as well as individual contributions so **thank you for your ongoing support.**

The congregation responded quickly and generously to the audio-visual fund set up in April. We are so grateful to families who directed memorial gifts to the fund, as well as St Stephen members and the Cruisers. Your contributions allowed St Stephen to complete installation of the audiovisual system in June. Additionally, St Stephen created a new staff position--the Digital Ministry Director—to develop and retain technical skills, as well as to develop a team of volunteers. We look forward to expanding St Stephen's outreach as we learn how this tool can be used. We welcome Zach Van Dyke as our Digital Ministry Director!

  heart for worship, Paige and Melissa became highly skilled digital editors and producers. St
  Stephen needs to develop this skill set/knowledge within our volunteers, as well as hiring
  knowledgeable staff.
- Congregational care needs reassessment/revigoration.

#### **Youth Ministry**

#### 2021 Annual Report

In the Fall of 2013 Melissa Stearns was hired as a part-time Youth Ministry Director. For four years she worked alongside Andrea Fluegel and Laurel Bornholtz as Part-time Children's Ministry Directors. With the departure of Laurel in 2017 Melissa took on both ministries as Children, Youth and Families Ministry Director. She excelled in both areas of ministry, (no small feat!) As Youth Ministry Director for the past eight years Melissa has developed a strongly relational program that fostered faith through service, learning, and fellowship. One of her strongest gifts is the ability to maintain communication with youth and parents in order to carry out the youth ministry programs. The consistency of the program was significantly disrupted with the onset of Covid-19. Yet, throughout shut-downs, cancellations, isolation and social distancing she continued to maintain a vigorous communication with the kids and families for which she was responsible, often bringing in friends and continuing that communication beyond high school. During the pandemic she took on diverse responsibilities, since youth activities were severely limited; most notably the production and editing of our pre-recorded on-line worship services. As we navigated the pandemic, she lobbied for increased, and responsible in-person events and learning opportunities. So that when worship services began to reopen in the spring of 2021, we were ready to quickly move from on-line learning and events to hybrid and in-person gatherings. In May we were saddened to learn that she had accepted a job as Children, Youth and Families Ministry Director at Redeemer Lutheran Church, a neighboring congregation. Since then our search to replace her has stalled and we began to consider other and 'out of the box' alternatives to a full time CYF Director. Those considerations led us to concept that both her new congregation and St. Stephen could benefit from a partnered youth ministry. Children's Ministry would be carried out by a part-time Director with moderate salary. We would share Melissa, as Youth Director and pay to Redeemer one half of one half of her salary and benefits package. This will bring the benefit of lower cost to each church, more kids to build a reasonably sized youth group and planning for one program instead of two different programs with the same goals. Both Church leadership bodies have approved this concept and we'll begin this partnered ministry in February 2022. I and the leadership group who has been working on this are excited about the possibilities and look forward to having Melissa around here one day a week and at youth events on site. We've also been working on developing a Collaborative Youth Ministry with a diverse group of churches in White Bear Lake.

In 2021 Youth Ministry carried out confirmation classes monthly in-person. Pre-confirmation was carried out weekly with a hybrid model of learning, some in-person and some by ZOOM. In fall we began joint confirmation classes with Redeemer on a monthly basis. In the spring the youth ministry, grades 5-12 carried out a Heggies Pizza Fund Raiser, to support the 9-12 grade Mission trip, and other summer events for younger kids. The Fund Raiser raised \$1,500.00. June and July held several events for children as well as youth. Then in July the Senior High group went on a mission trip to San Francisco, where they handed out hygiene packages, served sandwiches for unhoused people in 'the Castro', listened to guest speakers about being unhoused and experiencing discrimination, meditated in a labyrinth at Grace Cathedral and visited Alcatraz. They experienced a lot about the unhoused, about those with mental illness and the efforts being made by God's people to address those issues. Youth Ministry in the fall struggled to get organized.

I'm looking forward to 2022, continuing collaboration with Melissa, the National Youth Gathering, and regularly scheduled youth events. Let's make this work, to the glory of God and the benefit of God's people.

The annual Report of the Church Treasurer for 2021 consists of the following items:

<u>Balance Sheet</u>: Under Current Assets we have fluent cash assets totaling \$220,905.99. These cash assets consist of \$139,936.49 in our checking account; \$32,740.70 in our savings account; and 4 CD's totaling \$48,228.80. Please also note that we have not incurred any long-term debt. We are so very blessed to be in this position.

Benevolence Fund: Through pledged giving to our benevolence fund, we have been able to donate \$17,365.00 this past year to various non-profit organizations. We have a balance of \$1,249.87 remaining from our 2021 calendar year. I am very pleased to share with you that this past year we made donations to the St. Paul Ares Synod, Companion Congregation Lukani (Tanzania Scholarships and Tanzania Mission Trip scheduled for 2022), Tecate Orphanage and we provided a campership to Lake Wapogaset Summer Bible Camp.

<u>Capital Fund:</u> Through pledged giving to our capital fund (24,116.84) and the income received from Neighbors Helping Neighbors (6,000.00) we also received income from an insurance claim of \$36,730.00 and we received funds of \$20,976.83 for the new Digital Video System. This past year we were able to complete phase 1 of the furnace project at a cost of \$49,168.00, purchase and install a new Digital Video System at a cost of \$20,976.83 and repair the entrance to the church using insurance funds for \$36,730.00. We have a balance in our capital fund of \$97,886.06 remaining from our 2021 calendar year.

<u>Cash Reserve Fund</u>: This past year we were able to add an additional \$10,694.14 to our Cash Reserve Fund which existed of \$17,641.21 giving us a total of \$28,335.35.

<u>Current Fund</u>: We are offering one Sunday Worship Service on Sunday and we are continuing to provide GAP Worship Service on Wednesday Evenings and we were able to resume most of our programming and special events in 2021. We are truly blessed to be ending 2021 with **\$9,139.16** in our current fund account.

Special Designated Fund: The balance in the Special Designated Fund is \$85,923.56. This fund consists of several account categories. In our General Special Designated Accounts (800 account numbers) we have a balance of \$24,000.52. In the Funding Special Designated Accounts (810 account numbers) we have a balance of \$19,197.88. In our Tanzania Mission Special Designated Accounts (820 account numbers) we have a balance of \$21,982.29. In our Tecate Mission Special Designated Accounts (825 account numbers) we have a balance of \$2,900.00. In our Special Designated Memorial Accounts (830 account numbers) we have a balance of \$17,842.87.

This past year I have really enjoyed returning to worship services and I was truly grateful to be a chaperone in San Francisco with our youth. It is so very nice to see and hear the activity that has returned to our church. It truly is a blessing to serve as your treasurer. It is my intent to continue to be transparent, to keep lines of communication open and to serve in the best interest of St. Stephen. Please contact me if you have any questions or concerns,

#### 2021 Annual Report of the Synod

"Let us hold fast to the confession of our faith without wavering, for he who has promised is faithful." - Hebrews 10:23



This past year has been a wild ride. COVID-19 vaccinations opened a roadway to imagine more in-person gatherings just as political rancor made it less attractive to be together with those with views other than our own. Summer brought better weather for worshipping outdoors, fall programming was planned, and then a rise in infections from the Delta variant caused new caution and restraint in our church gatherings.

Across the synod, book groups were launched, tackling tough questions of racial justice and long overlooked inequities in communities of color. Leaders embraced important soul work to understand their own bias and resistance to change. Congregation councils wrestled in new ways to understand what it means to be the church today. Live streaming became common place in sanctuaries large and small.

Looking back, 2021 was both a tough year and a transformative time. Last January, did any of us really think we would still be wearing masks and keeping social distance the following Christmas? Yet, when challenged in so many ways, in congregation after congregation, we learned to **hold fast** to God's promised faithfulness; a wild ride indeed.

Undeterred by not being able to gather in person, at the digital Synod Assembly in mid-May, we launched the synod-wide Planting Hope Campaign. Over the next two years we will work together to raise \$2.75 million dollars to deepen the Spirit's work within and beyond the 109 congregations and mission starts of the synod. Your participation will help us:

- Invite neighbors into life in Christ;
- · Renew the congregations of the synod;
- Raise up the next generations of leaders;
- · Invest in a transformative project on the East Side of St. Paul
- with Lutheran Social Service of Minnesota.

The congregational phase begins now in early 2022 with congregations setting aside six weeks this year to introduce the campaign and to invite financial participation. More information on the Planting Hope Campaign can be found at https://spas-elca.org/planting-hope/.

This synod places high emphasis on raising up the leaders needed for the work of this synod and across the Evangelical Lutheran Church in America. Currently, 38 persons are in the candidacy process, preparing to serve as deacons or pastors. Five candidates were ordained this past year for service in the Saint Paul Area Synod. They include Pastor Tammy Wilkerson, Pastor Teleen Saunders, Pastor Amy Mihelich-Smith, Pastor Linqing Chu and Pastor Bristol Huffman Reading.

105 University Avenue West, St. Paul MN 55103 651-224-4313 | www.spas-elca.org In addition, during 2021, 20 persons were installed in new calls in congregations or in specialized ministries. That's a lot of call committee meetings, prayerful deliberations, and congregational meetings. How grateful we can all be that this work did not stop during the disruptions of the pandemic.

Amid the many changes in our communities, strong ministry requires lifelong learning. We are grateful to be in the third year of a generous grant from the Lilly Endowment to support the ongoing learning of pastors and deacons. In 2021, the nine members of the first round of the Second Act Cohort, for pastors and deacons in years four through 10 of public ministry wrapped up their two years together. Ten other pastors and deacons will form a second cohort in early 2022. They will be accompanied by mentors, more experienced clergy with a commitment to walk with rising leaders. Also, the Kubernesis Seminar, for those discerning a call to senior leadership positions, continues to meet quarterly and is eagerly anticipating their capstone sailing trip adventure in August of 2022. A third cohort for Leaders of Color continues to explore how best to invest the resources from the Lilly Endowment to deepen community, learning and support.

It is not enough to have strong, agile pastors and deacons; resilient lay leadership is also necessary for congregations to thrive. This past year, five congregations participated in a Liberating Structures cohort, learning together how to embrace new opportunities for deepening faith and expanded commitment to others beyond the congregation's walls. Three additional congregations are pursuing a tailor-made renewal process. Six congregations have participated in community listening and engagement training. Do you recognize your congregation's involvement here? If not, the synod staff is here to assist you.

While mission support for synod and ELCA churchwide work has been shared at 96% of that budgeted for the year, many congregations do worry about money matters and seek to strengthen their stewardship skills. This past year, nine congregations – perhaps including yours – participated in a year-long training called Stewardship for All Seasons. It is good to remember that none of us need to navigate these days without encouragement from others.

Pandemic restrictions on global travel challenged the synod's long-standing partnerships in the Iringa Diocese of Tanzania and in Guatemala but Zoom and video connections opened new ways to be a church that is both local and global. We are especially grateful that in March, Astine and Ryan Bose were able to begin their two years of volunteer service with Bega Kwa Bega in Iringa. God has shown us and our global partners new ways to be connected, habits which will endure long after the pandemic winds down.

Let me end with a special word of thanks to the synod staff. Along with Ryan and Astine Bose, Rolf Lowenberg-DeBoer joined the staff as an assistant to the bishop in March. Other staff include Michael Gold, office assistant; Pastor Justin Grimm, director for evangelical mission and assistant to the bishop; Peter Harrits, director of Bega Kwa Bega and assistant to the bishop; Deacon Krista Lind, assistant to the bishop; Anna Marsh, executive assistant to the bishop; Alicia Rodriguez, office manager; David Roinas, synod finance administrator; and Mary Smith, director of communications.

It has been a wild ride of a year and yet at every rollicking turn along the way, God's faithfulness has sustained us and those we are called to serve. **Hold fast**, we can say to one another. Please know what a joy it is for all of us to serve with you in the Saint Paul Area Synod.
