## St Stephen Lutheran Church Church Council Meeting Minutes, November 13, 2023

Marla Amborn called the meeting to order at 7:00 p.m.

## REPORTS:

Treasurer's Report - Mary Beth Skunes (Treasurer)
Treasurer's Report in its entirety for October is included for review.
Mary Beth has included a Summary page with the Treasurer's Report. Highlights:

- October income higher than normal, partly because of the Music Festival and Auction income and a $\$ 3,000$ anonymous donation, have not figured who it belongs to yet because it was from a bank.
- Expenses for October were higher than normal due to quarterly insurance payment of \$5,769 and the Holy Cow Survey cost of $\$ 1,080$, and finally payment to Redeemer for Melissa Whitman was missed in September so she was paid double in October.
Discussion on bank credit card - Need to get handle on the credit cards. Pastor Jim cancelled his card. Patsy Olson still has a card and it is in PK office in locked file cabinet. Melissa Whitman has the third credit card. There was a question if Melissa should have a card from Redeemer, not St. Stephen since she is employed by them. Mary Beth will talk to her. Would like to get this credit card cancelled and make decision on who should have card. Recommend Tami get a credit card. So will cancel card and re-issue to Tami, probably Mary Beth, Melissa Whitman, discussed whether Pastor Juli should have card. New Senior Pastor should have a card when comes.


## Council Minutes

2024 Budget - Mary Beth needs all Ministry Team council liaisons to talk with their ministry teams and get their ministry team budgets to Mary Beth by NOVEMBER 30. Ted said that if a ministry team identifies a project and feels money should come from a different ministry team, you need to discuss that with the other MT and decide which team needs to support it. Mary Beth is available to sit down with anyone this week to help with their budget. She is available to talk by phone or in the church office (10:00 am or after). Give her a call.

MOTION: A motion was made by Denise Ashley and seconded by Cheryl Skrypez to approve the October 2023 Treasurer's Report as presented. Voted on and carried unanimously.

Pastors' Reports - Interim Pastor Sharon Kelly and Pastor Juli Thompson
Reports from Pastors Kelly and Thompson included for review.
Pastor Kelly report - PK presented actual live stream participant numbers that Zac was able to get from his recording. We have numbers from January 2023 through current. Live stream numbers accurate as soon as worship concludes. PK feels having actual numbers during the service is more accurate. She presented information for the Sundays in October (5) and November (2). We need to make up our mind if we want to count the people who view later. PK feels live stream is more representative of "post-lockdown" viewing. Who is joining at actual time of the service. Kathy Stickler asked if there was cost of livestreaming? There is a small one, maintain cameras, need to fix equipment, paying the person who is running the livestream program. Also Zac gets an hourly rate when asked to do extra recording. What do you think about digital evangelism and read more books that talk about post-lockdown live stream. Mary Beth said that she anticipated in the wintertime the live stream numbers would go up. We need to make sure we are recording both the live stream view/in person count of people every Sunday.

Pastor Juli report - She wants clarity around her role during the time we will not have an interim. Since Juli was not present at the council meeting, the executive committee will meet with Pastor Juli separately to discuss this.

## Ministry Team Reports - ALL

Congregational \& Community Care - Phyllis Ballata
Phyllis presented information from Isaiah. There were listening sessions across MN. Thousands of people participated. They are now analyzing answers from all these listening sessions. She included a copy of their Faith Agenda which asks all elected officials to govern with the following in the
forefront: A democracy that honors every person's dignity and a caring economy that allows everyone to thrive. She also provided Isaiah key legislative victories in 2023. People from St. Stephen who participate in Isaiah are Phyllis Ballata, Pastor Juli, and Karen Smith.

Stewardship - Ted Field
Last Sunday was "Intent Sunday". Stewardship has received 43 statements of intent. Approximately half of what was received indicated a greater gift. Goal is to get more than 100 envelopes.

Fellowship -_Betsy Clark
The Music Festival and Auction was on Saturday October 14 with 80-90 people attending. Our net income from the event was approximately $\$ 5,500$.

## Worship and Music - Denise Ashley

Denise said that W/M may need to make some changes to the number of Christmas Eve service schedule. Possibly remove one of the services. Need to make final decision before Steppingstone gets mailed November 22. Will have a special meeting in the next week. W/M needing to add to 2024 budget organ repair at $\$ 7,500$. Some discussion whether memorial money could be used for that. Will be discussed as budget is prepared.

Nominating Committee Update - Mary Beth Skunes
The nominating committee was asked to find 3 three-year terms and 1 one-year term. The three-year terms will be filled by Nancy Finley, Jackie Colaizy, and Sue Lemon. The one-year term will be filled by Phyllis Ballata (who will be completing her one-year term at the end of this year). Marla informed Mary Beth that Bethany Zenner will not be able to fulfill her final year in 2024 and we are looking for an additional one-year term to fill. Mary Beth asked Denise Ashley and Cheryl Skrypez (both completing their one-year term at the end of this year) whether either one of them would be willing to serve one more year. Denise said the two of them would discuss and get back to Mary Beth.

MOTION: A motion was made by Phyllis Ballata and seconded by Kathy Stickler to approve the Pastors' Reports and Ministry Team Reports. Voted on and carried unanimously.
